



SoCal Explorer Competition Information Packet

The Fourth Annual SoCal Explorer Competition is scheduled for July 2025 at Otay Ranch High School in Chula Vista, CA.

This event is being hosted by CHP El Cajon and CHP Westminster Explorer Posts.

The competition is designed to be very demanding on the physical and mental capabilities of each Explorer. Events are designed to test the strengths and limitations of a person's intelligence, personality, demeanor, and physical abilities, as well as dedication and conviction to the Explorer Program. Explorers are given the opportunity to test their skills in real life situations including Felony Stops, DUI Stops, and Building Searches, just to name a few.

Our competition and training environments are designed to test an individual's skill and make them a better overall explorer. A **maximum of 32 teams** will be allowed to participate in this competition on a first come first served basis, so it is important to register early to secure your spot. Currently, **a \$500 deposit is required to secure your team's spot. Refunds will not be issued after Sunday, June 1, 2025.**

Friday, July 18 – SoCal Team Bonding Day – Lara's Labyrinth Escape Rooms (Team arrival times will be assigned approximately one month prior to the competition. Teams will have to arrive at the time assigned. There will be little to no adjustment in the times assigned to each team).

COMPETITION RULES

AGE OF PARTICIPANTS:

Exploring is Learning for Life's career-education program for young men and women aged 15 to 21 years of age.

ALL EVENT PROCTORS HAVE FINAL SAY AND THEIR DECISIONS WILL STAND.

Please note that all events (although not anticipated) are subject to change without notice.

WEAPONS USED IN COMPETITION SCENARIOS:

Each post must provide their own training weapons. All weapons in the Law Enforcement Events shall be training weapons.

All Training Weapons **shall** be distinctively painted so as not to be mistaken for an actual weapon.

Sworn advisors will be allowed to carry firearms while on school grounds. All officers carrying, will keep their weapons holstered. Sworn Advisors will NOT be allowed to carry a firearm into specific scenarios.

IMPORTANT INFORMATION:

The campus is a restricted flight zone and there will be no drones allowed. There will be a \$10,000 fine.

Teams are reminded that videos and/or photos of the scenarios should not be shared on social media platforms or with other teams during the competition. If a team breaks this rule, there will be points deducted from the overall score.

REGISTRATION INFORMATION

HOW TO REGISTER:

Please complete the registration form and email it to fpaez@chp.ca.gov with a copy of your payment by **Wednesday, May 16, 2025**. A liability form is **required** for each Explorer at the time of registration. Please note that **all** attendees must register (i.e. supervisors/managers, family members, friends, etc. are considered Spectators). If an attendee is not registered, they will not be allowed to participate in the SoCal Team Bonding Day and/or be a spectator during the competition. When your deposit payment and registration forms are received, a confirmation email will be sent.

FEES: A \$500 deposit is required at the time of registration to secure your spot.

The cost of this 2-day event is as follows:

\$150.00 per **Explorer** (with a minimum of 6 Explorers)

\$125.00 per **Advisor**

\$75.00 per **Spectator** (No Swag)

Each post must have at least one paid advisor in attendance per gender participating. Also, supervisors, managers, family members, friends, etc. are considered **Spectators**. ***Each guest must be registered regardless of days they will be in attendance, no exceptions.***

Refunds will not be issued after Sunday, June 1, 2025.

Each entry fee includes:

- SoCal Team Bonding Day – Lara’s Labyrinth Escape Rooms
- Food ticket (breakfast on Sunday and lunch both days), specialty coffee, beverages, snacks, and pastries (while supplies last)
